The Gaylord E. and Barbara K. Waddell Memorial Scholarships of \$1,000.00 per year (renewable for four years) will be awarded to **five** East Clinton, **three** Clinton-Massie and **three** Blanchester High School graduates in the class of 2018. The ratio of scholarships to each high school is set by the Waddell will, which established the scholarships. The number of scholarships to be awarded this year will be eleven.

Those applying for the scholarship must demonstrate adequacy for an institution of higher learning, good character and citizenship, seriousness of purpose and appreciable need for financial assistance. These scholarships shall be awarded to persons whose families are of middle or lower economic levels.

The recipient of the scholarship must maintain a 2.0 (out of a 4.0), or C average for all course work completed if the scholarship is to be renewed.

The recipient shall be enrolled as a full-time student in an institution of higher learning. A student in an institution of higher learning is defined as a full-time student in a post-high school educational program.

Persons receiving the scholarship must have maintained approximately a B or 3.0 average for all course work completed in high school. A grade level of 2.70 is established as a base for awarding scholarships.

The money connected with this scholarship shall be credited to the recipient's account at the institution of higher learning which the recipient chooses to attend. Payment of one-third of the scholarship's annual value will be made to colleges on the quarter system in August, November and February. One-half payment of the scholarship's value will be made to schools on the semester system in August and November.

**In order to renew this scholarship each year, recipients must file an official copy of their grades with the Superintendent of Southern Ohio Educational Service Center by July 1st.**

All materials within this application must be completed and returned to the local superintendent of each of the three school districts by no later than **March 23**. The final selection will be made by a scholarship committee chaired by the local superintendents and the Southern Ohio Educational Service Center Waddell Scholarship Committee. The educational service center scholarship committee must receive all scholarship materials and a priority ranking of each application by **April 6**. Announcement of the scholarship recipients will be made at graduation.
